# College pantry drive collects 80 lbs. of food

The first call for donations to a college food pantry was answered at the January general meeting with 80 lbs. of goods, plus \$30 in cash for Whatcom Community College. **Thank you, members!** 

Please bring donations of nonperishable items to the February meeting for Western Washington University. Roughly 8.6% of students on the campus, 1300 people, are classified as having very low food security. This means they substantially altered their food intake due to a lack of money or access to healthy food. Currently the Feeding Western program works to support and expand the service capacity of two on-campus food pantries.

## Members pen comments to the **U.S. Department of Education**

Letters written by Branch members at the January meeting joined over 103,000 other comments received by the U.S. Department of Education with responses about proposed changes to Title IX.

Unfortunately, the planned speakers for our January meeting were unable to attend, but member Roni Lenore ably filled in with information on Title IX changes proposed by U.S. Secretary of Education Betsy DeVos. Roni distributed postcards so members could send their own comments before the Jan. 28 deadline.

The Title IX proposal was officially unveiled in November, and DeVos will determine whether the changes will be adopted. However, Congress has the ability to overturn her decision. Failure to follow Title IX regulations can cost schools and universities federal funding.

DeVos has proposed narrowing schools' obligations in responding to sexual misconduct. Her proposal is a change from Obama-era guidance for Title IX, the federal civil-rights law that prohibits gender discrimination in schools that receive public funding.

The proposal has been denounced by many who believe it will allow schools to avoid dealing

The Other Walla, set in Walla Walla, WA is about the lives of undocumented high school students, their fear and concern for themselves and their families; and the discrepancies between their lives and those who are US citizens or otherwise documented. The Other Walla is playing at 1 pm Sunday, February 24 at WWU's Fairhaven College Auditorium.

2. The Unafraid is set in Georgia and follows three high school seniors brought to the US illegally as children, shielded under the Deferred Action for Childhood Arrivals (DACA) program. Watch the Dreamers jump through hoops, trying to go to college, finding they are ineligible for in-state tuition and cannot afford the full cost. This motivates them to take up activism and demand a change, but mounting obstacles get in their way. Their tenacity is inspiring; their struggles disheartening. The Unafraid is playing at 2:30 pm Saturday, March 2 at WWU's Fairhaven College Auditorium.

What a week it's been! Lilly Ledbetter joined us on Capitol Hill to celebrate the 10th anniversary of the Lilly Ledbetter Fair Pay Act, as well as the introduction of the Paycheck Fairness Act. AAUW's advocacy the last few weeks and months (and years) ensured that this bill was a top priority for the House of Representatives, earning it a coveted spot in the first ten bills introduced. We spent several days accompanying Lilly to a variety of lobby visits with members of Congress, allowing them to hear directly from Lilly why the Paycheck Fairness Act is so important. Lilly and I both spoke in the press conference for the bill's bicameral introduction on Wednesday, along with members of Congress and other equal pay advocates. At the press conference, House Speaker Nancy Pelosi committed to passing the bill out of the House by Equal Pay Day this year on April 2! This expedited timeline is in direct response to our advocacy. Deborah J. Vagins Onward!
