2019/2020 AAUW Bellingham Scholarships Awarded

AAUW Bellingham, with the prime mission of supporting education for girls and women, provides scholarship donations to Bellingham Technical College, Northwest Indian College, Western Washington University and Whatcom Community College. The amounts may vary from year to year, but recently we have been able to provide \$1000 each to BTC, NWIC and WCC. The WWU amount varies according to proceeds from the AAUW Bellingham Endowment established at WWU in the 1990s. This year, each WWU student received \$500 per quarter for three quarters of the school year, or \$1500 each from the endowment - a good year!

Bellingham Branch member's son-in-law brings rapid testing for COVID-19 to Whatcom County

Editor's note: I was so excited about this medical breakthrough in our community that I asked Susan Moen if she would "brag on" her son-in-law Greg Wolgamot for this newsletter. This was written by Susan's daughter Sara Mostad, MD, PhD. who is an infectious disease doctor at St. Joseph Hospital.

Greg Wolgamot, MD, PhD and Ryan Fortna, MD, PhD are pathologists here in Bellingham, who have applied every fiber of their ingenuity and experience to bring testing for COVID-19 to Whatcom County. They both work at NW Pathology and NW Laboratory. They decided

about two weeks ago that they could likely help with the problem of severely limited COVID-19 testing in Washington. Washington was the first state in the US to have a COVID outbreak. Our state is considered a 'hot spot' because of the early outbreak. The testing capacity of both the University of Washington and the Department of Health were rapidly overwhelmed early on. Northwest Lab (NWL) received a supporting letter from Washington State Department of Health to be designated high priority for initial distribution of COVID testing machines (PCR instruments), due to proximity to the rapidly expanding epidemic in Seattle.

Meanwhile here in Bellingham, 80 miles north of Seattle, the epidemic was growing and the hospital was filling with a large number of patients with respiratory symptoms. St. Joseph's Hospital was sending COVID tests to an out-ofstate lab contracted by the hospital which was taking 8-10 days to provide results. There was a growing sense of urgency for testing, as all efforts to triage and care for

patients, health care workers and the community were severely shackled by lack of ability to test. At one point last week, there were 64 people in the hospital with "pending" tests for COVID. To quote The WHO, "it's like trying to fight a fire blind-folded."

Greg and Ryan have both done PhD's in molecular bench science and have knowledge of and experience with the complex RT-PCR tests. NW Lab also has the input of other pathology colleagues and a highly capable operations crew. They believed they could manage to do the testing in Bellingham, but were not sure how they would get a large enough pool of skilled people run the test. Then one evening when he was out for a run, Greg ran into one of the biology professors from Western Washington University and realized that there were a lot of biology graduate students and lab assistants that were currently out of work while the campus is shuttered. He sent a letter to the WWU Biology Department, and within eight hours had ~20 grad students and lab assistants reply that they were eager to help with the COVID testing. Within 24 hours, they had 31 people from the Biology Department. Over the course of a weekend, they brought them in for orientation. credentialing and HIPAA-training.

Last week the instruments arrived and over the weekend the lab was able to validate perfect tests against a large number of positive samples sent from the Department of Health. On

March 30, they begin large scale testing of patient samples from the hospital, ER, long-term care facilities and local clinics. They did 265 tests the first day and will rapidly ramp up 24/7 testing, ultimately with capacity for 2000 samples per day. They are only the 3rd lab doing testing in Washington State (joining UW and Washington State Department of Health).

During the first 5 days of testing, 1344 patients were screened for COVID-19, 106 were positive. The availability of rapid testing has changed everything for being able to care for patients, health care workers and to help with timely outbreak investigation in the long-term care facilities and other clusters.

Last week, at the peak of testing delays, there were 64 patients in the hospital awaiting COVID results, including some patients on ventilators. Since we have starting testing locally at NWL,



that number is now actually down to "zero" patients in the hospital waiting for COVID results. Hospital samples are processed immediately, with results ready in a few hours.

Masks, anyone?

The CDC is now requesting everyone to wear masks in public, but many of us may not have the capability to sew one. If anyone who has been busy making them has some to spare, please email me, and I will send out an email to all our members, to see if anyone would like one or two.

From that point, members could arrange between themselves how to get them delivered. Maybe other members could serve as couriers - doorstep to doorstep. (I would volunteer for that.)
